### Innovative teaching methods

**Research description:** The aim of the research is to develop a novel pedagogical methodological subject for doctoral students in order to prepare future teachers for the use of innovative pedagogical methods in education.

More and more specialist literature deals with the changing information-learning style of Z-generation young people. The changed learning style also makes it necessary to change the teaching style of practitioners, including the motivation of students, their involvement in the educational process, the effectiveness of knowledge and ability development, and the effectiveness of the teaching-learning process.

For the content and methodological development of the subject, we conduct 10 in-depth interviews on the use of innovative online and offline teaching methods among university staff, so that we get an idea of the problems that go hand in hand with the use of these methods or lead to their non-application. In addition to this, we will explore the good practice of university staff teaching in other disciplines with a further 5 in-depth interviews. Involving them in the teaching of the subject, through their concrete practical examples we may present the possibilities of applying the individual methods (noting that most of the methods are not disciplinary specific).

Based on these research tasks will be as follows:

- 10 interviews with university lecturers
- Get to know 5 good practices from university teaching colleagues
- Preparation of Syllabus in English
- Compiling a Lecture note in English
- Developing Lesson plans
- Preparation of Accreditation materials

#### The The New Middle East and the Syrian Conflict

Research description: The aim of the research is to analyse the complex transformation process in the Middle East and North Africa, which takes place on the global, the regional and the local level. The focus of the research is the Syrian conflict, where the multifaceted transformation process emerges. In the Syrian conflict we can observe the importance and role of both the state and the non-state actors (in Northern Syria, the PYG has formed a de facto autonomous territory). The Syrian conflict is a civil war and a war at the same time. There is precondition for peace, which is a minimum consent both on the global and regional level. The research addresses the above-mentioned processes and the dynamical relations among state and non-state actors.

## **Implications of Public Health and Economic Security for International Relations**

Research description: The project aims to analyse security complexes in the fields of public health and economic security, with special regard to issues at the intersection of two these areas and their international implications, from region-wide and global epidemics and biological weapons/warfare to international burden-sharing in the field of public health.





### Drivers of migration of asylum seekers

**Research description:** The goal of this research is to map the indicators relating to the root causes and drivers of migration, with special emphasis placed on asylum seekers who hand in their asylum application in the Visegrad countries.

In migration studies one of the most popular analytical framework is that of Lee (1966), relating to push and pull factors of migration. Harris and Todaro (1970) drew up a framework where the migration decision is centered around expected wages. Later research argued that poverty and inequality in itself is not a driver of migration, as the poorest probably will not have enough resources to leave their home country (e.g.: Van Hear, Bakewell, & Long, 2018). This research will use the model established by Carling & Talleraas, 2016:6-7 who argue, that a differentiation can be made between migration aspiration (e.g.: poverty and other external factors) and migration decision (violent conflict). In the former case the citizen has not yet left their home country, but is thinking about leaving, while in the later case the decision to leave has been made.

While the destinaton choices of asylum seekers have been analysed by many authors (such as Melander & Öberg, 2007; Milton, Spencer, & Findley, 2013; Moore & Shellman, 2007; Neumayer, 2004, 2005) up to this date none of them have included the countries of Central and Eastern Europe (CEE) in their framework. Thus it is an interesting question to ask whether the number of asylum seekers increased in CEE because of conflicts in the country of origin, or because something drew them to the CEE region.

This research seeks to answer the following research question: which are those significant indicators (push and pull factors, root causes and drivers of migration) which influence asylum seekers in handing in their application for refugee status in a Visegrad country?

#### Policy problems and actors of Budapest's night-time economy

#### **Factors Affecting Government Stability in Visegrad Countries**

Research description: In recent years, reasons of government stability in post-communist countries have been a poorly researched field of political science. Hence, our research group aims at examining the various factors affecting the stability of governments in V4 countries. First of all, we focus on the institutional environment (e.g., electoral system, government's accountability to parliament, party discipline, etc.). Secondly, the party system shall be taken into consideration. In this dimension, not only the number of parties seems to be a relevant feature but also the nature of party competition, i.e. the relations of relevant political parties to each other, and the forms of party cooperation (e.g., joint lists, pre-election alliances, significant political blocs).





### **Hungarian political system (MPRK)**

Research description: The research group undertakes to collect, process and analyze documents, studies and research results related to the changes that took place in the Hungarian political system in the 2010s. The task of the students participating in the research will be to collect the Hungarian and mainly international works related to the movement, changes and directions of Hungarian politics, then to organize and analyze them under the direction of the head of the research group. In recent years, within the political science community, but also in the wider environment, there have been countless works that have attempted to interpret the movements and directions of Hungarian politics. Some of these have also had a serious impact outside the political science profession, the concepts they use (from the hybrid regime to the competitive authoritarian regime) have been incorporated into political journalism. The MPRK therefore strives to process and interpret all such available work.
