aa) Credit value of journal articles:

<sup>&</sup>lt;sup>2</sup> For the purposes of calculating the publication credits required for the absolutorium, for students having begun their doctoral studies after 1 September 2016 but before 1 September 2019, the higher journal article score should be attributed out of the two featured in Versions "A" and "B". During the degree acquisition procedure, however, students need to declare whether they request calculation pursuant to the "A", "B", "C" or "D" version.

If the journal in question has a higher ranking in the Scimago database than the one assigned to it in the list of international journals of MTA, the programme director making the assessment shall determine the value of the article in accordance with the Scimago system. If the journal in question has a higher ranking in the MTA list, that value must be taken into consideration. As the Scimago classification changes from year to year, the ranking associated with the year of publication of the given article or, lacking such, the last year in which it was ranked should be taken into account. As Scimago applies a far more differentiated disciplinary classification than MTA, the highest value must be taken into account in all cases.

By default, equivalance shall be established as follows:

\*20 extra points may be awarded in the case of journals ranked D1 in the MTMT Database (the best 10% of the journals that implicitly also belong to the Q1 category), 10 extra points may be awarded in the case of journals ranked Q1 in the MTMT Database, regardless of the number of authors.<sup>3</sup> (This condition may only be applied in Version A).

\*\*The Doctoral Schools mutually accept journals categorized by other Doctoral Schools as A,B or C .

ab) score of "book reviews" recorded in MTMT:

50% of the score that may be awarded in each category for a "book review". Not more than 1 "book review" may be taken into consideration among the peer-reviewed journal articles. If the "book review" was published in a D1 or Q1 journal, the applicable additional 20 or 10 points shall also be halved *mutatis mutandis*.

c) The maximum number of credits attributable for other outputs (text book, notes, presentation published in a non-reviewed conference publication, poster and study) is 10 credits in case they are in the Hungarian and 20 credits if they are in a foreign language.

d) For co-authored publications, the credits to which each author is entitled shall be calculated in accordance with MTA's credit rules:

In case of 2 authors	75% x credit value
In case of 3 authors	60% x credit value
In case of 4 or more authors	30% x credit value

(5) The publication criteria for obtaining the doctoral degree may be fulfilled by choosing either Version C or Version D below, irrespective of when the student was admitted to the doctoral program. For this purpose, students are not required to meet the 45/25 point requirement in organized education and the 100/60 point requirement in individual education. The credit reduction applicable to co-authored studies does not apply either.
