2. LEGAL BASIS FOR THE DATA PROCESSING

The post calling you to play will appear on Facebook and within the MyCorvinus app. The correct answer must be given on the Corvinus website.

The <u>https://www.random.org/</u> program is used by the University for the prize draw, but it records the prize draw candidates under pseudonyms in the program, so no personal data will be added to the program.

The Organizer will publish the winner's name on the University's website and in the Corvinus News.

After the Prize, the Organizer is subject to a contribution obligation, so the Organizer is also entitled to process the personal data specified in the applicable tax legislation.

4. ACCESS TO AND TRANSMISSION OF THE DATA, USING A DATA PROCESSOR

Only the staff of CUB [name of the organizational unit] have access to the data, for the purpose of performing their tasks and to the extent necessary, such as staff in charge of marketing, communication. The University discloses data to third parties only on the basis of a legal authorization or with the consent of the related person. In the course of this data processing the University does not use a data processor.

5. DATA SECURITY MEASURES

The University stores personal data on the University servers. Not any external company will be involved in storing. The University takes appropriate measures to ensure the protection of personal data, from unauthorized access, among others.

6. RIGHTS RELATED TO DATA PROCESSING

The person has the right to request information about data processing, the right to request to restrict of the data, to request blocking (restriction of data processing), and to request that the data controller disclose to him/her his/her personal data and the information related to the processing thereof. The individual concerned may withdraw his/her consent at any time. The person may request that his/her data be erased, however, after these data were published (e.g. in publications, leaflets, bulletins, on Facebook), there may be physical impediments to such erasure. In that case as well, the University will take any reasonably expected steps in consideration of the available technology and the costs of execution.

7. DATA PROCESSING RIGHTS ENFORCEMENTS

If you believe that your data protection rights may have been breached, you have the right to lodge a complaint with the applicable supervisory authority, or to seek a remedy through the courts.
