### **FAQ**

### for the Dissertation-proposal Support Grant

### 1) Do I need an active student status to apply?

A: Yes, because the scholarship can only be paid in an active semester. If your student status is terminated or suspended during the scholarship period, you have to pay back the scholarship.

2) In the application form I have to state, whether I have previously submitted any applications for financial support on the field of my research. I have already submitted an application and received a scholarship connected to the research topic, but I have not received any financial support for the dissertation proposal itself. What do I have to answer in the form?

A: In this case, please choose the answer "I did submit" and list the grants you have received on your dissertation topic. All grants awarded must be indicated on the application form, and there is a separate section on ongoing grants.

# 3) I have previously received support for a given research topic. In this case, am I eligible to apply

A: Within this application, we support the dissertation-writing process and the acquisition of your doctoral degree. Thus, if you have already received support for a given research topic, but not for the preparation of your dissertation proposal, you may be eligible for the scholarship. For each previous grant, the Evaluation Committee will examine the grants received individually and decide on eligibility.

#### 4) What kind of dissemination commitments do I have to make?

A: You have to indicate in your doctoral dissertation that you have been supported by this project. Furthermore, you have to give a conference presentation and release a publication in which you also indicate the fact of the scholarship support. In the case of latter two, no other source of financial support can be indicated, as it constitutes as double financing.

#### 5) What are the deadlines for the disseminations?

A: The dissertation proposal must be submitted by 30 June 2021. The results of the dissertation have to be presented in the form of a conference presentation by 30 November 2021. Also by 30 November 2021, you have to publish a peer-reviewed publication or journal article. If your publication is not publicly available by the deadline, we accept the official signed letter of acceptance of the given journal's or publication's editor too.

# 6) How do I have to indicate the project support on my dissertation proposal and other presentations and publications connected to it?

A: Please indicate the fact of project support as follows:

The present publication is the outcome of the project "From Talent to Young Researcher project aimed at activities supporting the research career model in higher education", identifier EFOP-3.6.3-VEKOP-16-2017-00007 co-supported by the European Union, Hungary and the European Social Fund.

## 7) What kind of conferences and publications can be submitted in the frame of my dissemination commitments?

A: Participation in a conference that qualifies as a domestic or international scientific conference in the given field of science is eligible. The participation in publications and conferences linked to so-called predatory journals (source: qualifying list of MTMT journals, or Beall list: <a href="https://beallslist.net/">https://beallslist.net/</a>) will not be taken into account.

### 8) Where do I find the work plan template? What do I have to know about it?

A: The work plan has to be prepared on a monthly basis. The work plan template is available at the link below, on the project website:

#### 9) How should I report my progress after the scholarship period?

A: You have to submit a short report on your activities carried out during the scholarship period that is to be handed in by 15 July (after the submission of the draft dissertation.

### 10) What do I have to submit to complete my dissemination commitments?

**In case of conference presentation:** Submit the abstract of your presentation, the conference call and conference program, a screenshot of the presentation with a list of participants, and the certificate of attendance.

In case of a publication: Submit the editorial letter of acceptance (place of publication, expected time), the publication in .pdf format, the availability of the publication (link), the MTMT link of the publication, and in case of a foreign language publication also its abstract in Hungarian. It is important that the

publication must be recorded in the MTMT database and assigned to Corvinus University of Budapest.
