# INTERNATIONAL SEMINAR

Each semester, KEDGE Business School organizes a major event called "International Seminar" twice a year, both in our Bordeaux and Marseille campuses. The objective of the one-week Seminar is to offer our graduate students (Master of Science in Management):

- the possibility to meet with and be taught by high-level professionals or academics.
- a wide range of topics in accordance with our modern vision of management.
- and also the education experience of International@Home.

The format of this Seminar is 30 hours course/pedagogical activities, with two sessions per day (morning and afternoon) from Monday to Friday. The seminar is based on an interactive pedagogy, on collaborative work; therefore, we cannot buy articles/cases/softwares to focus on teamwork.

Although the initial crisis of the ongoing Covid19 pandemic is behind us, many actors, such as governments, universities, companies, employees, and consumers, are still dealing with different issues and challenges. Therefore, we will prioritize European applications for the October Seminar and enlarge our horizon for the Spring semester applications. With this event, we aim to strengthen the faculty collaboration between our institutions. Meetings with our KEDGE Professors and Faculty members will be organized to facilitate a collaboration which can lead to a co-written article or a future COIL teaching.



# **PAYMENT**

Due to French laws, there is now only one contract status possible for you: "CDD" (short term contract). One hour of teaching is paid 100€ gross. After payment of the compulsory French Social Insurances, the Professors earns 84.97€ net per hour, which makes around 2549€ for one-week teaching.

### PLANE TICKETS AND HOTEL

The hotel is usually booked for a week (check-in on Sunday, check-out on Saturday). If you wish to stay a few more days in France for personal purpose, it will be on your own personal expenses.

Professors provide their travel plans to our travel desk: <u>cellule.voyage@kedgebs.com</u>. KEDGE BS pays the airplane ticket and the hotel in advance; the Professor receives an electronic ticket and booking confirmation.

The international team will submit your documents to KEDGE's Faculty. Professors selected by the Faculty will be contacted from mid-July to mid-Sept. for the **Fall seminar which will be held in October**, and from mid-Nov. to mid-Jan. for the Spring seminar which will be in next March 2022.

# 3. IF ACCEPTED.

To manage the administrative procedure in effect at KEDGE BS, Professor will be informed in Sept. for Fall, or in Jan. for Spring. At the same time, Professors will provide their travel plans to our travel desk: <a href="mailto:cellule.voyage@kedgebs.com">cellule.voyage@kedgebs.com</a>

HR will connect with the applicant to finalize the integration, for contract, one more before the start of the seminar.
