

CORVINUS UNIVERSITY OF BUDAPEST 2021/2022 FALL SEMESTER FINAL EXAMINATION PROCESS

Final examination periods

Preliminary Final Examination period in DECEMBER: 7 semester-long study programs except Business Informatics between December 6-11, 2021

> Final Examination period in JANUARY: Every study program (full-time, part-time) between January 17-29, 2022

Exam period for students who will take the Final Examination in January: between January 3-8, 2022

1. The conditions of releasing a student to take the final examination:

- obtaining the final certificate*,
- submission of the thesis by the deadline and evaluation of the thesis with a grade other than fail according to Study and Exam Regulations, which also includes the application for the final examination,
- the student does not have any payment obligation towards the University at his/her given program,
- the property of the University has been returned (books borrowed, sports equipment, etc.).

*The University issues a final certificate/degree (**absolutory**) to the student who fulfilled the study and examination requirements as well as the practical/professional training prescribed in the curriculum with the exception of the language examination and the thesis/diploma work, prepared the thesis/diploma work and gained the prescribed credits in the maximum length of the training period. Those students who registered for courses in the Fall semester 2021/22 must have **all their grades entered in Neptun**

by Monday, November 29, 2021 in case of a final examination in December 2021
by Monday, January 10, 2022 in case of a final examination in January 2022, otherwise they will not be allowed to participate in the final examination.



Attention!

Students who are planning to take the final examination **is January 2022**, but will not have all their grades in Neptun by the deadline - January 10, 2022 – can get the missing grades by the end of the examination period (of non-graduating students) **BUT** in this case they will not be able to attend the final examination in January 2022, only a semester later in June 2022.

2. Final Examination

The Final Examination and the evaluations related to it (comprehensive examination, thesis defence, and portfolio defence) will be conducted in person.

3. General conditions of the Final Examination

With the final exam application, the student is responsible for

- accepting the rules and conditions of the final examination process,
- acknowledging the consequences of violating the final examination rules,
- identifying the student itself by presenting any identification document (ID or passport) before the start of the final exam,
- sending in the thesis defence presentation, which could be required by some institutes or departments, to the responsible department 24 hours prior to the final examination with the Neptun code stated in the file name.

4. Repetition of the Final Examination, fees, deadline (87§ Study and Exam Regulation)

In case of a repeated final examination a fee stipulated in the RSFB (Annex 5) is required to be paid (via bank transfer):

- first retake: 10,000 HUF
- second or any additional retake: 50,000 HUF

Payment can be made via bank transfer or SimplePay.

5. Withdrawing the final exam application (84§ Study and Exam Regulation)

- The student may withdraw the application for the final examination.
- However, the thesis submitted cannot be withdrawn in this case either.
- The application shall be submitted by no later than 3 days before the start of the final examination.
- The application shall be submitted via Neptun on a form issued by the University.
- If the student has no grounds for exclusion, the University shall accept the student's application by automatic decision and shall not take a separate decision or other decision on this. In this case, the provisions on the repetition of the final examination shall not apply.

6. Information the diploma issuing (88§ Study and Exam Regulation)

Prerequisites of issuing the diploma is the successful final examination and thesis defence.

Attention!

Please check,

- If all your language certificates are in the Neptun system.

In case you experience any differences or you have a language certificate but it has not been registered in the Neptun system yet, please show it in the Student Service Area during opening hours

- Before the 10th of December if the final exam will be in December 2021
- Before the 28th of January if the final exam will be in January 2022

In case the student **passes the final examination successfully but does not meet the language requirements** prescribed in the programme and outcome



requirements or is not in possession of the required language exam, the diploma may still be issued.

7. Issuance of the diploma certificate

After from January 3, 2022 "Diploma certificates" will be sent to students (to the email address registered in Neptun) who have applied for a master's degree starting in the spring semester 2021/2022 and are entitled to receive a diploma.

8. Termination of student status

The student status is terminated on the last day of the given semester, in case of a final exam during the Preliminary Final Examination period, it is terminated on the last day of said period (January 11, 2021).

9. Graduation ceremony

By special provision depending on the epidemic situation.
