

# ***Rules and Regulations for the use of the Gym***

## ***Ferenc Földes Dormitory***

Dear Residents, the gym of the BCE Földes Ferenc Dormitory is a private club, therefore we kindly ask you to follow the following rules to ensure the continuous cultural access to the sports facilities. Use of the gym services implies acceptance of the Rules and Regulations.

### **1. Payment of additional service charges, registration:**

- 1.1. A facial record of the residents using the sports services of the gym (hereinafter referred to as "users") will be kept.*
- 1.2. By accepting the gym pass, the user accepts the Rules and Regulations of the Gym and acknowledges that compliance with them will be monitored by the Dormitory staff.*
- 1.3. The Dormitory shall use the data of the Resident solely for its own records and shall not disclose them to any third party.*
- 1.4. The use of the gym is subject to the presentation of an immunity card.*
- 1.5. The gym pass fees are paid via Neptun.*
- 1.6. The use of the gym is restricted to the residents of the BCE Földes Ferenc Dormitory.*
- 1.7. The gym has a card access and the presentation of a photo ID is compulsory for the dormitory staff or the person in charge of the reception.*
- 1.8 In the event of irregular use or transfer to a third party, the user's right of use may be suspended.*

### **2. One the whole area of the gym the below are FORBIDDEN:**

- 2.1. smoking and alcohol consumption.*
- 2.2. to be drunk or under the influence of drugs on the premises!*
- 2.3. consuming or abusing drugs, illicit doping substances, narcotics!*
- 2.4. any activity that disturbs others with strong noise, smell or other environmental nuisance!*
- 2.5. taking any dangerous substances and/or objects (explosives, pyrotechnics, weapons), alcoholic beverages of any kind or animals!*
- 2.6. commercial activities, advertising, propaganda, (billboards, stop signs, wall stickers and leaflets), sound and visual material, illegal gambling or the sale of products without the permission of the dormitory!*

### **3. Special rules:**

- 3.1. Access to the gym area is only allowed in sports equipment suitable for the sporting activity taking place on the sports field!*
- 3.2. The use of closed, clean sports shoes is obligatory in the entire gym area.*
- 3.3. Drinks may only be brought into the gym in sealable plastic bottles.*
- 3.4. Users are obliged to pay particular attention to their own personal hygiene, if they do not do so, they will not be allowed to use the gym services.*
- 3.5. To avoid accidents, there must be a minimum of 2 users in the gym at any one time.*

### **4. General rules:**

- 4.1. The written and unwritten rules of civilised behaviour, order and cleanliness must be observed in the gym area.*
- 4.2. The staff working in the dormitory area has the right to draw the attention of the users to the correct use of sports clothing and equipment!*
- 4.3. After using the machines and equipment, all users must leave the machines in their original position and the equipment in its regular storage place.*
- 4.4. The use of towels is obligatory during training sessions.*
- 4.5. The use of a disc locking screw is obligatory for the use of stackable weights!*
- 4.6. Before the start of the training session, it is in your own interest to check the equipment to be used and if you notice any malfunction, you must immediately report it to the dormitory at [foldeskoli@uni-corvinus.hu](mailto:foldeskoli@uni-corvinus.hu).*
- 4.7. The use of the gym services by residents under the age of 18 is only allowed with parental permission.*
- 4.8. The gym is available between 6 am and 11 pm.*
- 4.9. The gym is opened by the reception staff with a key at 6 a.m. and closed at 11 p.m. The gym must be vacated by 11 a.m.*
- 4.10. Once a week on Wednesday between 10:00 and 11:00 the gym is closed for cleaning.*
- 4.11. Everyone must observe the opening hours of the gym and leave the gym on time in view of the closing time.*
- 4.12. The fee for sports services must be paid in advance at the beginning of each academic semester.*
- 4.13. These Regulations may be modified or extended at the discretion of the Dormitory Management.*

## **5. Taking responsibility**

*5.1 Corvinus University of Budapest shall not be held responsible for any damage to persons or material property resulting from non-compliance with the present Rules and Regulations, the House Rules and Regulations or the irresponsible behaviour of the users.*

*5.2. Corvinus University of Budapest shall not be held responsible for lost or stolen objects or equipment!*

*5.3. All users are obliged to hand in found objects to the reception desk on duty and to provide documentation!*

*5.4 All users use the services and equipment at their own risk and responsibility!*

## **6. Extraordinary event**

*6.1. In the event of an accident, an accident report must be drawn up in the presence of the reception staff and the senior assistant on duty. Any incident occurring on the premises of the gym must be reported to the reception desk without delay by the first user to notice it. Depending on the emergency, telephone notification should be made without delay:*

*Ambulance (in case of accident):104*

*Fire brigade (in case of fire): 105*

*Police (in case of disorder, theft): 107*

*General emergency call (in any case):112*

## **7. In case of disorderly behaviour:**

*In case of misconduct (violation of the rules of these regulations or of the generally accepted rules of conduct), the offender will be warned, and if this is not successful, the receptionist and/or the senior assistant on duty and/or the staff member of the dormitory will be entitled to ask the resident to leave or to exclude him/her from the membership, either temporarily or permanently. In cases beyond the scope of their authority, the representatives of the residence halls are entitled to request the assistance of the police or other authorities, who will instruct all concerned to cooperate. An expelled guest who is in breach of the rules may not make any claim against the Dormitory.*

*The BCE Földes Ferenc Dormitory Gym Operating Regulations were approved by the Campus Director on 09/09/2021 and will come into effect on 13 September 2021. The Gym Operating Regulations will be published on the BCE Földes Ferenc Dormitory website and a certified copy will be kept by the BCE Földes Ferenc Dormitory Dorm Manager.*
