Call for Applications

for participation in international student mobility programmes for study purposes

in the 1st and 2nd semesters of the 2023/2024 academic year

1.§ Subject matter of the call

This Call for Applications sets out the conditions for participation in international mobility programmes offered by Corvinus University of Budapest (hereinafter: CORVINUS or the University) on the basis of an inter-institutional cooperation agreement (bilateral or multilateral contract) and applies to all mobility programmes operated by CORVINUS, including:

- 1) ERASMUS+ programme, and
- 2) other programmes based on an inter-institutional cooperation agreement (bilateral or multilateral treaty) not within the framework of the ERASMUS+ programme:
 - a) CEMS,
 - b) double or multiple degree programs,
 - c) other programmes based on an interinstitutional cooperation agreement (bilateral or multilateral contract) not covered by points 1) and 2) a) and b).

International mobility places awarded under this call do NOT ALWAYS come with financial support! Financial support is provided for in Section 12.

2.§ Legal and regulatory background to the call for applications

The general rules for participation in mobility programmes are set out in the Regulations for Terms Abroad, and for doctoral students in the Doctoral (PhD) Regulations and the rules of operation of the relevant doctoral academic institutions.

In addition to the previous section, the rules applicable to each programme are set out in the following regulations and other provisions:

- 1) In the case of ERASMUS+, the Erasmus Charta, Erasmus Programme Guide, sponsorship agreement between Corvinus University of Budapest and Tempus Public Foundation.
- 2) other programmes based on an inter-institutional cooperation agreement (bilateral or multilateral treaty) not within the framework of the ERASMUS+ programme:
 - a) In the case of CEMS, the common requirements set out by the CEMS Association on the https://cems.org/ website, and the application criteria indicated on the Corvinus website: https://www.uni-corvinus.hu/main-page/programs/cems/application/?lang=en define the rules for participation

b) for double- or multiple-degree programmes, a cooperation agreement between the universities

c) in the case of other programmes based on an interinstitutional cooperation agreement (bilateral or multilateral contract) not covered by points 1) and 2) a) and b), the cooperation agreement concluded between the universities.

The rules for the recognition of degrees are set out in the Study and Examination Regulation ("Tanulmányi és Vizsgaszabályzat" - TVSZ), and in the case of doctoral students, in the Doctoral (PhD) Regulations and the operating rules of the relevant doctoral school.

3.§ Aim of the call

The aim of the call is to enable students with excellent academic results, who are able to perform well at Corvinus partner universities, to participate in the most suitable mobility programme, in order to broaden their horizons, deepen their professional knowledge and build international contacts with their fellow students abroad, which will also help them in their future professional life.

4.§ Time and method of submission of applications and timetable for the application procedure

Applications can be submitted between 9:00 9th November 2022 (Wednesday) and 12:00 22nd November 2022 (Tuesday).

Scheduled date and time of the oral interviews:

CEMS: between 23 Jan 2023. and 3 Feb 2023.

double degree: 1 Feb 2023. and 28 Feb 2023.1

Deadline for evaluation of the applications: 20 March 2023.

Students participating in a PhD programme must submit an official letter of acceptance (which is a prerequisite for application) issued by an authorised member of staff of the partner university (lecturer, researcher from the institution applying for the affiliation). If it is not available by the above deadline, then by 24:00 on 10 February 2023 at the latest. Study and

The document proving the language proficiency required by the foreign university, i.e. an international language certificate not older than 2 years (provided that the B2 level is otherwise available), must be submitted by 24:00 on 10 February 2023 at the latest. No points can be given for the language certificate submitted in this way.

5.§ How to submit the application:

The application and all attachments and other documents must be submitted via MOBility Manager, unless otherwise specified in this call for applications.

¹ Elements of the selection process that require the involvement of applicants (e.g. oral interviews, etc.) but which have not been specified or announced at the time of the call, will be communicated to candidates in due course (at least 3 working days before the date set), indicating the date and, if possible, the venue. Notification can be made by bulletin board, by publication on the website or by e-mail.

Proof of the language proficiency required by the foreign university, i.e. an international language certificate no more than 2 years old (if B2 level is otherwise available) and, for PhD students, the letter of acceptance from the foreign university or equivalent document, may be sent to corvinus.erasmus@uni-corvinus.hu. No points can be given for the language certificate submitted in this way.

6.§ The coordinator of the call and the evaluator

1. The coordinator of the call for proposal:

- 1) In the ERASMUS+ programme, Student Services and International Relations and Accreditations are responsible for the coordination of the call.
- 2) other programmes based on an inter-institutional cooperation agreement (bilateral or multilateral treaty) not within the framework of the ERASMUS+ programme:
 - a) In the CEMS programme, the CEMS office is responsible for the coordination of the call.
 - b) For double- or multiple-degree programmes, the Student Services and International Relations and Accreditations are responsible for coordinating the call;
 - c) for other programmes based on an interinstitutional cooperation agreement (bilateral or multilateral contract) not covered by points 1) and 2) a) and b), Student Services is responsible for the coordination of the call.

2. The evaluator of the call for proposal:

- 1) In the ERASMUS+ programme: Student Services, International Relations and Accreditations, the programme directors, the Students' Union
- 2) other programmes based on an inter-institutional cooperation agreement (bilateral or multilateral treaty) not within the framework of the ERASMUS+ programme:
 - a) in the CEMS programme: the CEMS Office, a CEMS lecturer, a CEMS corporate partner, the CEMS programme manager or the CEMS Corporate Relations Manager and a representative of the CEMS Club
 - b) in the double- or multiple degree programme: the programme director, together with a lecturer and a representative of the Students' Union in case of an oral interview
 - c) for other programmes based on an interinstitutional cooperation agreement (bilateral or multilateral contract) not covered by points 1) and 2) a) and b), Student Services, International Relations and Accreditations, the programme directors and the Students' Union are responsible.

7.§ Who is eligible to apply

1. For all programmes:

- 1.1. Corvinus University of Budapest students pursuing an undergraduate, divided or one-tier postgraduate or doctoral degree programme may apply with conditions as follows:
 - a) students studying under the Stipendium Hungaricum and Diaspora scholarship programmes are not eligible to apply;
 - b) undergraduate students can only apply if they have completed at least two (2) semesters at Corvinus at the start of their mobility.

- c) undergraduate, divided or undivided postgraduate degree students may apply only if they have to complete at least 21 credits before they can obtain their degree, provided that the 21 credits do not include the compulsory internship and the thesis seminar, while for PhD students the number of credits awarded by the host institution abroad may not exceed the maximum number of credits specified in the Regulations of the Doctoral (PhD) Programme and the rules of the relevant doctoral school;
- d) Only students who have an active student status at Corvinus University of Budapest during the semester abroad can participate in the mobility programmes.
- 1.2. In the application process, students may only indicate partner institutions in the first five places in their field of study (see Annex 3 for the list of partner institutions by field of study). From the sixth place onwards, they can also nominate a partner institution in another field of study. Attention! However, the rules set out in Section 9. § 3. must be observed when the application is being assessed.
- 1.3. Students who are pursuing studies in more than one degree programme at the same time must indicate in their application from which degree programme they are applying for the mobility programme and only their results related to the chosen degree programme (e.g. number of semesters completed, average number of credits per semester) will be taken into account when assessing the application.
- 2. In the case of participation in the CEMS programme, the conditions of eligibility set by the CEMS office apply.
- 3. In the case of participation in a double or multiple degree programme, the applicant is subject to the terms and conditions of the partnership agreements concluded by the universities.
- 4. In the case of participation in other programmes based on interinstitutional cooperation agreements (bilateral or multilateral contracts) other than those referred to in points 1 to 3, the conditions of application laid down in the partnership agreements concluded by the universities apply.
- 5. In each academic year there are typically two application periods: in the first period (this call), students can apply for both autumn and spring semester studies for the next academic year (2023/24), in the second period (if there are places left for the spring semester), students can only apply for the remaining spring places (second round of application). Students who are awarded an international mobility place in the main call for the spring semester of the academic year 2023/24 and do not withdraw by 15 March 2023 will not be eligible to apply in the second round.

8.§ Eligible activities

Only the following activities carried out abroad are accepted for mobility for learning purpose:

- 1. full-time study in a higher education undergraduate, postgraduate or doctoral programme leading to a recognised diploma or degree: e.g. compulsory, compulsory elective and elective modules (mobility programmes are not available for solely thesis writing purposes);
- 2. For students on a PhD programme, research supporting the preparation of a dissertation.

9.§ Eligible places

Conditions for participation in the University's mobility programmes:

- 1. Studies can be carried out at higher education institutions abroad with which Corvinus University of Budapest has a valid student mobility partnership agreement.
- 2. Students participating in a PhD programme may only apply to a partner university from which they have an official letter of acceptance or a clear written confirmation of their acceptance, agreed in advance and documented by the collaborating partner (the lecturer or researcher who is affiliated to the institution).
- 3. In the application, applicants will establish an order of preference of a minimum of three and a maximum of ten institutions of their choice. The order of preference and the semester selected cannot be changed after the submission of applications.
- 4. Applicants may only nominate partner institutions related to their field of study in the first five places. From the sixth place onwards, it is possible to chose a partner institution from another discipline, but students from the field of study indicated at the institution will have priority in filling these places in the MOBility Manager. The list of disciplines is set out in Annex 3 to the call for applications.
- 5. Before submitting the application, applicants must check that the institution they wish to apply to does not have any requirement(s) that would prevent them from studying abroad (e.g. a language requirement that exceeds the minimum conditions complex B2 in the language of study).
- 6. It is the responsibility of the applicant students to check the course list of the universities for the period applied for and the language of the modules before submitting the application. If the course list for the semester of the mobility is not available during the application period, they can find out about the course list of previous semesters.
- 7. It is the students' responsibility to check the course list of the universities they are applying to before submitting the application, as the courses taken at the partner institution must be accepted at Corvinus.

10.§ The mobility (support) period

This call for applications is open only for mobility in the 1st (autumn) and/or 2nd (spring) semester of the academic year 2023/2024.

11.§ Application to be submitted

The application must be submitted via the MOBility Manager.

There is no possibility to re-submit missing documents, except for language exams and doctoral letters of acceptance, which can be submitted until 10 February 2023. Section 4 §.

Only activities that have been completed in full by the deadline can be included in the application (e.g. an ongoing professional course or foreign language course does not count, but certified professional work that is still ongoing in the semester of the application does).

Mandatory application material:

- a. online application
- b. a motivation letter (no signature required) in the language of study of the first three institutions applied for, using the form available in the MOBility Manager Documents section.

- c. For PhD students, a detailed research plan and work plan (signed by the student) instead of a motivation letter.
- d. an electronic copy of all valid documents proving the language skills (only the highest level of language certificate per language needs to be uploaded). **Important**: at Corvinus, IELTS, TOEFL and TOEIC language exams obtained more than 2 years ago are also accepted in this call for applications. However, if the host institution requires an international language certificate, it will only accept a language certificate issued no more than 2 years ago. (Applicants must have a valid language certificate at the time of placement, at the time of departure and, in many cases, throughout the mobility period, as required by the host university. Accordingly, they must provide proof of language proficiency in their application, i.e. a language certificate issued within 2 years.)
- e. any other document (signed) certifying the activities and results to be taken into account in the evaluation of the application, as set out in the table of Activities in Annex 1.
- f. For PhD students: official letter of acceptance (signed) or equivalent written confirmation by email.
- g. any activities in a student organisation or at a college for advanced studies must be confirmed on the O₃6₅ form provided in MOBility Manager
- h. earlier activities (2021-22 or older) in a student organisation or at a college for advanced studies must also be verified (signed) by completing the template in the MOBility Manager Documents section.
- i. any teaching assistant activity must be certified (signed) by filling in the template in the MOBility Manager Documents section.
- j. to certify a professional course or studies in a foreign language, students can upload the credit certificate (transcript) document downloadable from Neptun under Information/General Forms to the MOBility Manager.

12.§ Financial terms

- 1. Students who are awarded may receive the following ERASMUS+ funding depending on the country, the mobility period and other conditions (e.g. equal opportunities, green travel):
 - 1.1. ERASMUS+ scholarship support
 - 1.2. on-travel support
 - 1.3. equal opportunity support
 - 1.4. special needs support
 - 1.5. green travel support
- 2. In the case of visits to countries (outside the EU) under bilateral agreements, the University may award scholarships to the successful applicants in accordance with the following order of priorities, subject to the available funding (According to the rules of the Erasmus program, the winning applicants will receive the maximum support that can be given from the program based on the length of the mobility and the travel distance.)
 - 2.1. Students travelling to the following partner universities:
 - Bentley University (USA)
 - University of Richmond (USA)
 - University of Michigan- Ross Business School (USA)

- 2.2. Students participating in the CEMS programme in order of the students' scores in this call for applications up to a maximum of the first 10 students applying for a bilateral place, subject to the amount available. In the case of equal scores, the students' undergraduate degree average decides the order.
- 2.3. DD programme participants taking into account the cumulative adjusted credit index of the students (minimum 4.00) up to the amount available
- 2.4. Support awarded on an individual consideration basis.
- 2.5. Great Britain students with a cumulative adjusted credit index of 4.50 or more will be supported, up to the amount available.
- 2.6. The remaining amount will be awarded to students based on their score in the terms abroad application, up to the amount available. In the case of equal scores, the student with the higher cumulative adjusted credit index will receive the support.
- 2.7. In case of withdrawal, the next student in the order of priority will be awarded the support. E.g. in the case of a Great Britain withdrawal, the next highest scoring applicant to Great Britain can travel.
- 3. For universities not participating in the ERASMUS+programme, we will keep the students informed of the funding schemes available other than those detailed in Section 12.
- 4. In addition to the above, students who have been awarded an international semester abroad may apply for a Scholarship for Partial Studies Abroad in the semester abroad, based on the Student Requirements (Part 4, Section 31 of the Regulation on Student Fees and Benefits). ATTENTION! Applicants should be aware that the ERASMUS+ and other available scholarships cover only a part of the actual costs, the difference must be covered by the student.

13.§ Decision-making and announcement of results

- 1. In mobility programmes, the evaluator will assess the merits of applications from students who:
 - a. have submitted their application on time and in full using the SUBMIT APPLICATION button in the MOBility Manager interface (Section 4-5)
 - b. meet the minimum requirements for admission (see Annex 1: grade point average, language criteria);
 - c. based on their score, there are still places available at the universities on their preference list.
- 2. Applications from students who do not fall into the categories listed in point 1(a) to (b) will be rejected by the decision-maker without any examination of the merits. For students who do not fall into the category of point 1, point c, the University may announce the remaining places from which students can choose, based on § 14.
- 3. <u>The applications submitted</u> are reviewed formally by the Student Services (hereinafter: HSZ) Mobility Group, and in the case of PhD students, the Corvinus

- Doctoral Schools, and then the applications submitted by the deadline and in due form are assessed according to the evaluation rules described in Annexes 1 and 2.
- 4. After the evaluation of the application, the partial scores will be published by the HSZ on the website, with the Neptun code of the applicants. Applicants will be informed of this by the HSZ.
- 5. Students may submit a complaint against the partial scores in two areas, language and other professional activities, within three (3) working days of notification of the scores, to corvinus.erasmus@uni-corvinus.hu. The subject of the e-mail should be "Complaint".
- 6. The HSZ will decide on the complaints within 10 working days and will notify the applicant by Neptun message.
- 7. In order to determine the overall score of the applicant, the HSZ Mobility Team collects the applicants' average academic results weighted by credits from Neptun.
- 8. Based on the above (the partial score and the score calculated from the creditweighted grade point average), the HSZ Mobility Team will aggregate the scores of the applicants.
- 9. The Head of International Relations and Accreditations (hereinafter: NKA) decides on the places awarded on the basis of the aggregated scores and the order of preference indicated by the applicants.
- 10. The decision of the NKA leader will be communicated to students on the <u>webpage</u> by 30.03.2023 at the latest. Applicants will be informed of this by the HSZ.
- 11. The applicants must accept the higher education institution awarded on the basis of their score and preference list.

14.§ Allocation of remaining places, scholarship support for bilateral places

- 1. The NKA may advertise the remaining places during the application process to those who have met both the formal and professional requirements of the application, but do not have a place left at the institutions on their preference list. Applicants who do not choose one of the places offered by the deadline will not be able to participate in the mobility programme announced in the given semester, and will be able to apply again during the secondary round of application.
- 2. Once the application for the remaining places has been closed, the HSZ will publish on the University website (with the applicants' Neptun code) the names of the students who have applied for bilateral places and who have already been confirmed as ERASMUS+ scholars: these will include the students who have been accepted to the listed US universities, as well as a specified number of students who have been accepted to the DD and CEMS programmes.
- **3.** The other applicants who have been awarded a bilateral place will be notified whether they have been awarded an ERASMUS+ scholarship after the closure of the 2023 second round of application.

15.§ Remedies

Applicants have the right to appeal against the decision of the head of the NKA (including the rejection of the comments) within 15 days of the notification or, if they have not been notified, then of becoming aware of the decision, pursuant to Sections 57-58 of Act CCIV of 2011 on National Higher Education. The request for redress can be sent to corvinus.erasmus@uni-corvinus.hu. The first-instance decision-maker shall examine the appeal in accordance with Section 44 of the Procedure for the Assessment of First Instance Applications and Legal Remedy Requests in Relation to Student Status. If they agree with the request, they shall,

within eight (8) days of receipt of the request, revoke, amend, correct or supplement the decision requested for review, or make up the omitted decision. In case of disagreement, the person proceeding in the first instance of the student's case shall submit the appeal, together with all available documents, comments and opinions, to the Student Review Committee within eight (8) days.

The Committee for the Review of Students' Judicial Remedy Appeals decides on the appeal in accordance with the procedure set out in the Student Requirements System, Procedure for the examination of applications at first instance and appeals concerning student status.

16.§ Extension of the mobility period, multiple participation in the mobility programme

The possibility to extend the mobility period within one academic year to participate in several successive mobility programmes at the same higher education institution or at different institutions is open to those who have achieved outstanding results in both their studies at their home country and abroad, and who still need to obtain at least 21 credits in the extended mobility period (the following cannot be included in the minimum of 21 credits: compulsory internships, thesis seminars, courses taken with preferential study schedule during the semester abroad) in order to obtain a pre-degree certificate stating that all course-units have been completed.

For extensions or additional semester(s) at another university, the rules for the first semester abroad apply. The extension must be requested before the start of the extension period, but no later than 30 November, by sending the downloadable "extension request form" available on the website: ERASMUS+ Partial training - Corvinus University of Budapest (unicorvinus.hu)

Applications for mobility programmes are assessed on a scale of 1 to 100 points as follows.

1) Credit-weighted grade point average

1a) Credit-weighted grade point average: max. 30 points

The *minimum requirement for* participation in mobility programmes is a **credit-weighted grade point average** of 3.0 or above, calculated as follows:

For students who are planning to study abroad at their current level (bachelor or master), the credit-weighted average of the following semesters will be taken into account for the scoring:

- The total number of semesters of study already completed at the intended study level abroad (bachelor or master), for the course of study covered by the application, including the cumulative grade point average weighted by the credits for the semester of the application period;
- For students completing their first semester, the grade point average of the first semester is taken as the weighted grade point average of the semester of the application period.

The calculation will be based on the weighted grade point average as defined by the Examination and Studies Regulation (TVSZ), with equal weight given to all semesters assessed.

If applicants are studying more than one course in parallel, they must specify in their application which course they intend to pursue in relation to their placement, and only

the data related to that course will be taken into account for the average calculation and all other questions.

2) Language skills: Max. 20 point

IMPORTAN: Only language exams uploaded to the MOBility Manager during the application period can be taken into account for the calculation of extra points for the students' language exams.

Applicants must declare their mother tongue in their application.

2a) language of studies: maximum 13 points

The *minimum requirement* for participation in the mobility programmes is to have a language exam corresponding to the Common European Framework of Reference for Languages (CEFR) level B2 or equivalent (intermediate general type C) in the language of the selected courses at the international institution. This is considered by the host institutions as a prerequisite for nomination, so points can only be awarded for a higher level of language proficiency.

If the applicants' mother tongue is the same as the language of study, they will receive maximum points in the language of study category.

2b) other language relevant to the course (language of the country of destination): maximum 8 points

2c) any language relevant to the course and knowledge of languages other than mother tongue: maximum 4 points

(More than one language is acceptable, but only the highest level per language will be considered.)

3) Other professional activities

3a) Other professional activities: max. 33 points

The table below applies to all undergraduate and postgraduate students admitted <u>BEFORE September 2022!</u>

Other professional activities of undergraduate applicants must be assessed on the basis of their undergraduate course, whereas of postgraduate applicants it must be assessed on the basis of their undergraduate and postgraduate course, in accordance with the table below. Each activity must be supported by appropriate supporting documents (even if carried out at other higher education institutions), no score will be awarded if these are not provided.

For the classification of student organisations, the following should be taken into account (applicants must indicate the date of the activity concerned):

- Spring 2020 accreditation should be taken into account, so it is the currently awarded category that counts, not the previous one.
- If the organisation does not currently exist/is not accredited, the most recent category awarded will be taken into account.

- If students refer to a previous activity (but not older than 5 years), the category to which the student organisation belonged at the end of the students' active activity will be taken into account.
- If students have completed their student organisation activities before the new accreditation system came into force (autumn 2019), the category achieved in the first accreditation in autumn 2019 will be taken into account.

If students are pursuing a Master's degree, the undergraduate activity is also worth points. If students have not been a member of a student organisation or a student council accredited by Corvinus University of Budapest, they can receive points for their past verified activities based on the S2-K2 categories.

4) Motivation letter in the language of study: max 17 points

Applications must be accompanied by **1 motivation letter** for the first three places of application in the order of preference. The motivation letter must be filled in using the form available in the MOBility Manager interface.

The main aspects of writing a motivation letter:

- It must be written in the language of the studies to be carried out at the university concerned (where appropriate, the motivation letter may be multilingual in the section on universities if the student is applying to institutions in different languages);
- In the motivation letter, applicants must provide a **concrete preliminary plan** with a list of courses to be taken at the chosen institution in accordance with the requirements in the home country (list the names of the courses chosen, indicate the courses already taken and those still to be taken and refer to their availability at the foreign institution (the courses list offered by the target university)).
- If applicants intend to take courses in more than one language at the same institution, they should prepare their application in the language that will dominate their studies;
- The motivation letter should explain why the institutions are relevant to the student's studies or career;
- The motivation letter should describe the student's objectives for the mobility programme (e.g. to increase professional competence, broaden horizons)

Work plan maximum 20 points

Publication output maximum 20 points

Successful complex exam maximum 10 points
Pro rata completion of credits maximum 10 points

PhD students cannot gain extra points for language skills, but they must have a B2 language exam in the language of study/research and meet other language requirements set by the partner university.
