Project title: The role of experts in deliberation within and among organizations

Project description*: I planned to examine the role of experts in deliberation in intra and interorganizational settings. The motivation behind the project was that, on the one hand, different actors show an increasing desire to participate in deliberations about what actions to take, both inside organizations (e.g. businesses, universities, social movement organizations) or in interorganizational settings (e.g. partnerships, cross-sector collaborations). In this sense, there is a renewed interest in democratic organizing. On the other hand, environmental and health crisis, such as the Covid19 pandemic, have made very visible the role of experts such as biologists, climatologists, epidemiologists, and doctors. This raises the question about how to combine democratic deliberation (publicly or inside an organization) and the authority obtained from knowledge. In fact, experts have been called "problematic participants" in deliberative settings. My goal was to write a theoretical piece about this topic, which is relatively unexplored in the areas of business ethics, stakeholder theory and of democratic organizing, using as a starting point Henrik Ibsen's play "An Enemy of the People" and based on the contributions from deliberative democracy theorists as well as organizational scholars on this topic.

Achieved result(s)*:

During the period of the visiting fellowship, I read extensively on the topic within deliberative democratic theory as well as within organization scholars using actor-network theory (as can be seen in the reference list of the manuscript). Actor-network theory was a new field for me, and I discovered that it has made important contributions about the intersection between science and society. Notably, Michel Callon and his colleagues have discussed hybrid forums in which scientists and laypeople interact on issues such as nuclear waste, genetically modified food and orphan



diseases, among others. These insights have enriched my initial ideas on the subject and, for example, led me to cast some doubt on Habermas' strong dichotomy between the language of science and the language of the lifeworld. I have submitted this work as a conceptual essay to Academy of Management Review. For essays based on works of literature or philosophy, AMR advises to submit first a 5-page proposal (1 single space) to the editor. I did this first step in early May and received encouragement from the editor. At the end of June I sent the full manuscript, which is currently under the regular review process.

In addition, during this period, I have been working on another project in parallel with two coauthors from ESADE, about the use of Ostrom's ideas on the "commons" as an alternative form of organizing. We have reviewed the literature on this topic, which is starting to grow and attract some interest, and have written an article which classifies the ethical claims and challenges surrounding commons organizing. This work has been submitted to the Journal of Business Ethics, and is currently under review. The link with the other work is that we suggest that democratic participation is the main claim that underlines the different forms of commons organizing, whether it be the management of natural resources or online platforms.
