

References – general information



Why to use?

- > To avoid plagiarism
- > To support your findings, thoughts
- > To provide information that others can locate the source themselves

Type of citation

- > Verbatim citation: word by word, quotation mark, no longer than 3-5 sentences.
- > Paraphrasing: summary of a longer text with your own words

Where to use?

- ➤ In-text add author, year
- ➤ Reference list list all references you have used

Help!

- > References FAQ
- > Turnitin: Turnitin Plagiarism Spectrum

Reference list - Compulsory data



Common sense: indicate as many data as necessary to identify a document.

- > Books: Author/editor, title, publication place, name, year (page number and ISBN are optional.)
- > Book chapters: chapter title, author, page number + (after) In: all other data as in case of books
- ➤ Journal article: Author's name, article title, + (as it is defined by the standard) + In: Journal title, volume, issue, page number (from-to). ISSN is optional.
- ➤ Electronic article: see journal article + DOI (digital object identifier) or access data (URL, database, date of access).
- ➤ Web-content: Author's name (if not available, then webpage name), year, title, URL, date of access.

For all the details check APA style

Turnitin - Text similarity checking software



Sources

- > own archive: previously uploaded materials by Turnitin users
- > online sources
- > licensed content: academically published materials

Text similarity checking at CUB

- > through Moodle
- > cca, one month before thesis submission deadline
- > at least one test uploading is guaranteed
- > set up by the university, uploaded by students
- ➤ Analyis overview guide for student

BUT: opponent's decision

Plagiarism, if: paraphrasing and citations together exceed 50% of the paper - even if everything is cited correctly.

Frequent mistakes, misconduct

Unintentional cases

- > Length of verbatim citations
- Inserting false paraphrase, quantity of paraphrases
- Cross-reference = in APA-style: <u>secondary sources</u>
- > Translations (4. § (8))*
- ➤ In-text citations and items in reference list do not match (9. §, 2/a)
- > Formal mistakes:
 - > missing quotation marks (,") (9. § 2/c)
 - > missing citation data (9. § 3/c)
 - ➤ Inconsistent, unfollowable citations (9. § 3/a,b)
- > Self-plagiarism (10. §, 1/a)
- ➤ Submitting a paper which was entirely or in most part written by someone else (10. §, 1/c, d)

Reference manager softwares - Live demonstration



- > Required style: APA (6th ed.), APA (7th) in the library
- ➤ Zotero, Mendeley, Endnote Web (WoS)
- ➤ Use of Zotero
 - Download (software + Connector)
 - > Structure
 - > Downloading documents
 - ➤ Making bibliography
 - > Cite-while-you-write plugin
 - > Synchronization
