CORVINUS UNIVERSITY OF BUDAPEST ON THE BASIS OF THE REGULATIONS FOR TERMS ABROAD INVITES APPLICATIONS FOR

Scholarship to support participation in international student mobility programmes for study purposes for the 1st and 2nd semester of the academic year 2024/2025.

Background:

In December 2023, the Government of Hungary established the Pannonia Scholarship Programme.

The Maecenas Universitatis Corvini (MUC) Foundation, which supports Corvinus University of Budapest, also provides funding for students travelling abroad for international study.

The purpose of this call for applications is to provide financial support to students who have been awarded a study abroad place for the academic year 2024-25.

1. § The aim of the application

Application for a scholarship for the 1st and 2nd semester of the academic year 2024/2025 for participation in a study abroad programme from the Pannonia Scholarship Programme and from the MUC or other sources.

WARNING! Applicants should be aware that the Pannonia Scholarship Programme, the scholarships provided by the MUC and any other scholarships available from cover only part of the actual costs incurred, the difference being covered by the student.

2. § Eligible applicants

All students who have been validly awarded a place in the "Call for applications for part-time study abroad" announced on 06.11.2023.

3. § Documents to be submitted

There are no documents to be submitted in this application.

4. § Deadline for submission of applications: 03.05.2024.

5. § Where and how to apply

The application must be submitted via the Neptun platform, on the "Study Abroad Scholarship Application for the academic year 2024/2025" application form .

- 7. § Study conditions for the application

There are no academic requirements for this application.

8. § Financial conditions of the application

The scholarships available under the Pannonia Scholarship Programme, as well as those from the MUC or other sources, are uniform depending on the destination countries:

§ 9 The assessor of the application

The Head of International Relations and Accreditations (NKA) decides who will be awarded a scholarship to participate in a study abroad programme, and how much financial support they will receive.

The decision of the Head of the NKA will be set out in a decision by 17.05.2024. Decisions are generated in Neptun by Student Services.

§ 10 Evaluation criteria

The criteria are the same as the criteria in the call for applications for the "Scholarship to support participation in international student mobility programmes for study purposes" published on 06.11.2023.

Article 11 Remedies

Applicants have the right to appeal against the decision of the head of the NKA (including the rejection of the complaints) within 15 days of the notification or, if they have not been notified, then of becoming aware of the decision, pursuant to Articles 57-58 of Act CCIV of 2011 on National Higher Education. The appeal must be submitted to the Student Appeals Committee and submitted in Neptun, on the "Remedies - Study Abroad Scholarship Application for the academic year 2024/2025" application form.

The Student Appeals Committee will decide on the appeal in accordance with the procedure set out in the HJR.

The time limit is thirty (30) days, excluding the periods provided for in paragraph 15(3) of the HJR, in particular the period during which the administration of the case is suspended at university level (i.e. the period of university closure).

Evaluation criteria

1. Eligibility criteria for students who have been awarded a non-bilateral (**current Erasmus+)** place:

The resources currently available are allocated according to the following principles:

- 1.1. Students travelling to partners in current Erasmus+ partner countries have priority over students travelling to bilateral partners.
- 1.2. Students participating in the CEMS programme have priority over other students, up to the amount available.
- 1.3. CEMS students are followed by students who have been awarded a place on a Double Degree programme and DSG programmes, in order of their starting number of places on the Abroad part-time programme, subject to the amount available.
- 1.4. The remaining amount will be awarded to students on the basis of their score in the main part of the training competition (this competition), up to the amount available. In case of equal scores, the student with the highest cumulative grade point average will be awarded the grant. In case of withdrawal, the next student in order of priority will be awarded the grant.
- 2. For visits to countries under a **bilateral** agreement (outside the EU), the University may award grants to the successful applicants, subject to the following order of priority, up to the available funding (the successful applicants will receive the maximum basic grant under the Erasmus rules, which will be awarded from the programme based on the length of mobility and the distance travelled.) The funds available at any given time will be distributed among the students who have been awarded a place in **this call** and have applied for funding, as follows:
 - 2.1. Students travelling to the following partner universities:
 - Bentley University (USA)
 - University of Michigan- Ross Business School (USA)
 - 2.2. Students participating in the CEMS programme in order of the students' scores in the study abroad competition, up to a maximum of the first 10 students applying for a bilateral place, subject to the amount available. In the case of a tie, the average of the students' undergraduate degrees will determine the order.
 - 2.3. Participants in the DD programme taking into account the students' cumulative average academic results (minimum 4, 00) up to the amount available.
 - 2.4. Support awarded on an individual consideration basis.
 - 2.5. Great Britain students who apply in this call and who have a cumulative grade point average of at least 4.50 will be supported, up to the amount available.
 - 2.6. The remaining amount will be awarded to students on the basis of their score in **this call**, up to the amount available. In the event of equal scores, the student with the highest cumulative grade point average will be awarded the grant.
 - 2.7. In the event of withdrawal, the next student with a place in this call will be awarded the grant.
