### **Basic concepts**

#### References: cited external sources

#### Why to cite?

- They prove that you are familiar with the topic.
- They support your ideas, thoughts and provide the possibility of comments
- To let others retrieve the original sources.
- to give credit to other authors
- To avoid plagiarism.

Exception: facts and data that belong to general knowledge do not require citation

The carrot contains vitamin A.– No citation is necessary. Vs.

The sweet taste of carrots is determined by the di- (sucrose) and monosaccharides (glucose and fructose) they contain (Northolt et al., 2004). – Citation is necessary.

#### Plagiarism

- using external sources without citing
- submitting a paper which was entirely or for the most part written by someone else

## **Basics of references**

- APA: CUB recommended, widely used in economics and related fields
- be consistent in the complete paper, use the same style in the entire paper
- wide range of different document types, ability to recognize them
- add as much data as necessary for a source to be retrievable (data elements)
- place of references: in-text list of references
- form of in-text citations: narrative parenthetical
- paraphrase direct quotation
- secondary source citation

### Where to cite?

In-text<sup>1</sup>:

#### • parenthetical (sentence end)

"Heavy social media use can be linked to depression and other mental disorders in adolescents" (Taylor, 2021, p. 43).

#### narrative (embedded in the text)

Taylor (2021) found that "heavy social media use can be linked to depression and other mental disorders in adolescents" (p. 43).

#### At the end of the paper:

Reference list

Taylor, W. (2021). Heavy social media use and psychological distress among adolescents. Front Public Health, 11(4), 43-53.

In-text citations and publications in the reference list must match.

<sup>1</sup>APA is not a footnote style; do not put citations here, but content-related information.



## **APA-reference style – in-text citation**

- Recommended in CUB
- Latest version: <u>APA 7th</u>, 6th edition is available on <u>APA's webpage</u>; changes are shown

### Form of in-text citations in parenthetical mode:

- Paraphrase:
  - o author's surname, year (Smith, 2021), (Smith & Jones, 2021), (Martin et al., 2020)
- Verbatim citation: author's surname, year and page number (indicating as p.): (Smith et al., 2018, p. 470).

### Form of in-text citation in narrative mode:

- Paraphrase:
  - o author's surname, year: Smith (2021), Smith & Jones (2008), Martin et al. (2018)
- Direct citation:
  - Author is embedded in the sentence, page number with p. comes at the end of the sentence, e.g.:

Bloom (2017) stressed that "poor empathy development has been associated with negative outcomes" (p. 23).



## **APA-reference style – Reference list**

### **Basic formal features**:

- Comes at the end of the paper, starts on a new page
- References are listed alphabetically, using the authors' surname
- If there is no author or editor, or in case of law, the title is used for listing
- No numbering, no bullet points
- List a maximum 20 authors
- 20+ authors: list 19 ... last author:

## Specialities for business documents

Keep basic rules, but reference necessity depends on the audience

- internal demonstration not necessary
- bank, investors, stakeholders proves your plan is well-grounded
- academic purposes, e.g. formal competition follow the basic rules

#### **Business proposal**

- There is no "official" style for citing business sources in APA
- Business readers consume most content electronically
- Business writers usually cite with hyperlinks and descriptive language about the link

Challenges with hyperlinks

- Clicking on hyperlinks interrupts the negotiation process
- the creation date of the hyperlink is unknown
  reasonable usage of current information needs to be proved
- hyperlinks may not be revealed by partners (paywall, licensing restrictions)

To avoid the challenges above, provide footnotes/in-text citations and a complete list of supporting resources.

## How to do? – In-text

- Be specific (provide the specific section in the website e.g. a report section, not generally a website title)
- abbreviated version of the citation is adequate e.g.:
  - BCC Research estimates the global market for internet of things (IoT) sensors was \$10.9 billion in 2021 (BCC Research, 2022)
  - Ethan Brown, Impossible Foods CEO, noted that consumers were choosing more comfort foods during the pandemic instead of prioritizing healthy options (WSJ, 2022)

Citing your own work

- if you use your own expertise to support the plan, provide relevant biographical information (to explain you are a credible subject matter expert)
- place it at the end of the executive summary, e.g.:
  - ...This proposal is informed by ten years of industry experience in this market. For further information on my experience, see Appendix...
- In Appendix provide some resume information



# How to do? – Reference list

- Place it at the end of your proposal
- provide a list of supporting resources
- organize your sources by section of your proposal, not alphabetically, e.g.

# How to do? – PPT - presentation

- no guidelines in APA for ppt-presentations
- you can use the same format on slides as in other documents' in-text citations

**Required elements** 

- date published/or date accessed online
- author/authoring organisation
- title of the source
- hyperlink/any other information that helps to find it (if any)

2 options for list of references in ppt:

- create an extra slide containing all cited information with large fonts
- create a references handout

### Example

#### Smart Phone Market Share

- Android has 61% of the smart phone market in 2012 (IDC, 2012).
- "Canadians are still buying BlackBerrys more than any other smartphone, in stark contrast to the mobile whims of their southern neighbours" (Berkow, 2011).

# A lifesaver - ZoteroBib

- ZoteroBib is Zotero's simplified version
- Free, open-source citation generator
- Easy to use
- Creates citations in different styles, but does not create in-text citations
- No installation, no account, no ads
- Works effectively, but correction might be necessary

Examples of further business sources

- Not officially APA, but created with APA-contribution
- Contains examples from the well-known business sources
