<b>ON CERTAIN RULES FOR ELIGIBILITY FOR ADMISSION IN MATHEMATICS TO BACHELOR STUDY PROGRAMMES</b>		

### Scope of the Provision

#### 1.§

- (1) This Provision applies to all applicants applying for admission in the admission procedure of the Corvinus University of Budapest for bachelor study programmes in the fields of business and management sciences and Computer Science and Information Technology.
- (2) According to Section 2 (4) of Annex 1 of the Admission Regulations, the scope of this Provision also extends to the bachelor study programme in Philosophy, Politics, Economy.

### Subject of the Provision

#### 2.§

- (1) The present Provision defines the results specified in Section 2 (2) ah) of Annex 1 of the Admission Regulations, which are required to fulfill the admission requirements in Mathematics in the bachelor programme in business and management sciences and in Computer Science and Information Technology.

### The results

#### 3.§

- (1) For the purposes of eligibility under paragraph 2 (1), the minimum results set out in Annex 1 to this Provision shall be deemed acceptable in the terms of the admission requirements in Mathematics.
- (2) Any examination of the results shall be conducted by the competent study programme leader or the Associate designated by him/her.

### Closing provisions

#### 4.§

- (1) This Provision shall enter into force on the day of its publication and shall remain valid until withdrawal.
