### Purpose of the Provisions

#### 1. §

- (1) Under the Regulations on Student Fees and Benefits (Part 4 of SR), the programme cost for specialist postgraduate study programmes are set by the Executive Committee in the form of Provisions.

### Scope of the Provisions

#### 2. §

- (1) The scope of the present Provisions covers
- a) all the specialist postgraduate study programmes offered by the university, and
  - b) the students taking part in specialist postgraduate programmes.

### Principles

#### 3. §

- (1) The amount of the programme cost may differ for Hungarian nationals and persons with the same rights as Hungarian nationals on the one hand, and for third-country nationals on the other.
- (2) The competent dean, in agreement with the Vice-Rector for Education, makes a proposal to the Executive Committee with regard to the programme costs, taking into account market needs as well as financial and professional criteria.

### Concessions

#### 4. §

- (1) <sup>1</sup>A concession from the programme cost of specialist postgraduate programmes may be granted to applicants who meet at least one of the following conditions. The reduced co-cost for Specialist Postgraduate programme are set out in Annex 1 to this provision.:
- a) *Alumni discount*: The applicant is an alumnus/alumna of the Corvinus University of Budapest.
  - b) *Early bird discount*: The applicant applies during the preferential application period advertised for the application in question and pays the programme cost by the payment deadline for that application or submits an official invoice request by that date.
  - c) *Volume discount*: At least 3 persons from the same customer (company, NGO, other legal entity, including groups of companies) are enrolled in the same programme during the same enrolment period.

- (2) <sup>2</sup>*ESG Consultant Discount*: A discount on the cost for the ESG Management/Specialist Economist postgraduate programme may be granted to applicants who also enrol in the ESG Consultant specialised knowledge training within the same semester, thereby establishing student status in both programmes and has paid the tuition fee for the ESG Consultant.
- a) The amount of the discount on the ESG Management/Specialist Economist postgraduate tuition fee will be equal to the tuition fee for the ESG Consultant specialised knowledge training.
  - b) If the student terminates their student status in the ESG Consultant specialised knowledge training (while maintaining student status in the ESG Management/Specialist Economist postgraduate programme), they must pay the full tuition fee for the ESG Management/Specialist Economist postgraduate programme for the semester affected by the termination and for any subsequent semester(s).
- (3) For individual orders from companies, a discount may be offered on the basis of a specific agreement. The amount of the discount shall be decided jointly by the relevant dean and the Vice-Rector for Education and shall be set out in the agreement.

### **Final provisions**

#### **5. §**

- (1) The present Provisions shall enter into force on 15 November 2024.
- (2) Simultaneously with the entry into force of the present Provisions, the Provisions of the Presidential Committee No. 10/2023 on the programme cost of specialist postgraduate study programmes shall be repealed.
