

**Call for Applications**  
for Corvinus Scholarship  
under the 2026 institutional admission procedure for applicants for admission  
to full time  
International Master of Business Administration (MBA),  
Finance,  
Management and Leadership (CEMS)  
master programmes offered in foreign languages, commencing in September  
2026.

The Corvinus University of Budapest (hereinafter: University), based on Sections 25, 26/A and Point (13) of Annex 1 of the Regulation on Student Fees and Benefits (hereinafter: RSFB) constituting Part 4 of the Student Requirements, Volume III of the ROO, hereby launches a call for applications only for foreign students for the Corvinus Scholarship (hereinafter: Scholarship) announced within the framework of the 2026 admission procedure for programmes in foreign languages (institutional admission procedure) **from the autumn semester of the 2026/2027 academic year** to the English-language, full time International Master of Business Administration (MBA), the Finance and the Management and Leadership (CEMS) master programmes (hereinafter: supported programme) as follows.

- 1.) **The purpose of the Corvinus Scholarship is:** to assume all or part of the tuition fees (hereinafter: programme costs) payable by students admitted to self-funded programmes through an institutional admission procedure, based on the performance of the students.
- 2.) **Eligibility conditions:** The scholarship is open to students who have applied for one of the following English-language master programmes of daytime delivery, announced in the institutional admission procedure for the 1st (autumn) semester of the 2026/2027 academic year:
  - International Master of Business Administration (MBA),
  - Finance,
  - Management and Leadership (CEMS)Students who would cover the full amount of the programme cost from their own resources, without external support, are eligible to apply for the scholarship.
- 3.) **Maximum number of Corvinus Scholarship holders allowed under the application:** 60 people, 20 people per programme. (If the maximum number of places in a study programme is not used, the remaining places cannot be transferred to another study programme.)
- 4.) **The amount of the scholarship:** up to the programme cost of the given programme as published in Annex 2 to the RSFB.
- 5.) **Eligibility for the scholarship is lost in the following cases** (and disbursement is terminated):
  - a) the training contract between the University and the student is terminated for any reason, from the date of termination;
  - b) the student's student status at the University is terminated, from the date of the termination of the student status;
  - c) the student switches for another programme, i.e. study programme or for another mode of delivery or language of instruction within a given study programme, from the date on which the student starts studying in the new programme;
  - d) the student has exhausted the maximum number of funded semesters under Section 25 (11)-(13) of the RSFB, from the next semester;
  - e) the student has exceeded the period of eligibility under Section 25 (14) - (15) of the RSFB;
  - f) the student fails to meet the academic requirements defined in Point 13) b) of Annex 1 to the RSFB within the review procedure under Section 26/A (3) of the RSFB, from the next semester.

The cases in which there is an obligation to repay the scholarship are provided for in Section 25 (26)-(27) of the RSFB.

- 6.) **How to apply for the scholarship:** you can apply for the scholarship through the **Dream Apply** (DA) system. Application period: **from 10:00 on 03 November 2025 until the available scholarship**

**places are filled, but no later than 12:00 on 13 August 2026.** No additional documents are required in addition to those required for the institutional admission procedure.

- 7.) **Decision on awarding the scholarship:** the Dean responsible for the given programme portfolio shall take a decision on awarding the scholarship. Decisions are made during the application period, in each admission period, on the basis of the ranking of students who meet the admission requirements in that period.

The minimum requirement for awarding the scholarship is that in the admission procedure the applicant obtains at least 75 points in the case of Finance or Management and Leadership (CEMS) programmes, 90 points for International Master of Business Administration programme.

Criteria for ranking applications:

- a) meeting the requirements for 'conditionally accepted' admissions status in the institutional admissions process (as in Annex 2 of the Provision of the Vice-Rector for academic programmes 9/2025 foreign-language programmes announced for foreign nationals – Procedure for scheduling the admission procedure 2026 for programmes starting in September)
- b) the number of admission points achieved by the applicant (*if the dates of receipt are identical*)
- c) in the case of identical number of points, the time of application on the official application interface (*as early as possible*)

- 8.) **Establishment of grantee status:** the grantee status is established after the decision on admission made under the admission procedure, based on the student's number of points, and after enrolment, with the training contract. A further condition for establishing the grantee status is that the student has a valid bank account in the same currency as the currency of the scholarship, recorded in Neptun.
- 9.) The requirements regarding the eligibility for the scholarship are set out in Section 25 (5)-(15) and (17)-(20) of the RSFB and Section 26/A (3)-(5) of the [RSFB](#).
